ASSESSMENT REGULATIONS AND COVID19

Academic Council approved a number of exceptional assessment arrangements in June 2020 to support students in the light of unprecedented disruption to learning and teaching due to the COVID19 pandemic. These <u>exceptional arrangements</u> were applied to progression and award outcomes in AY 2019-20. A separate 'fair assessment' approach' was applied to progression and award outcomes in AY 2020-21, in light of the ongoing impacts of the pandemic. Both sets of arrangements continue to be relevant for some students who were enrolled in those years, particularly part-time students.

ACTION SHORT OF A STRIKE (ASOS)

In June 2023, Academic Council approved temporary adjustments to policies and procedures in light of action short of a strike (ASOS) relating to the academic standards and quality regulations, in particular for assessment and Exam Boards (AC22-78).
