





The aggregate score at UHI was 84%. This was 4.1% higher than the Sector benchmarking group. The most positive and negative statements compared to the benchmark are below: The score for 'Resources: Computing facilities' was 95%, 16.0% above the Sector benchmarking group. The score for 'Resources: Library facilities' was 75%, 12.0% below the Sector benchmarking group.











Comparing UHI to the Sector benchmark, the most positive statements were:	UHI	Sector	Difference	Significance

3: I have access to the specialist resources necessary for my research (n = 61)	72%	80%	-7.9%	


The graphs in this report show the PRES scores for this institution compared to the benchmaking group.








Difference between UHI and Sector benchmarking group, by subject



History and Philosophical Studies. (n=6) had the most positive results at UHI relative to the Sector benchmarking group. Within this subject, UHI had an aggregate score 13.4% higher than the Sector benchmark. The subject most negative relative to the Sector benchmarking group was Other Health subjects. (n=10), with a score 1.8% lower than the Sector benchmark.

Within History and Philosophical Studies. (n=6), comparing UHI to the Sector benchmark, the most positive statements were:	UHI	Sector	Difference	Significance


Difference between UHI and Sector benchmarking group, by area



Relative to the Sector benchmarking group, Responsibilities was most positive, with a score 9.7% higher than this benchmark. The area at UHI most negative relative to the Sector benchmarking group was Teaching, with a score 10.4% lower than this benchmark. Research culture was also relatively negative, with a difference of 0.3%.


Aggregate score for UHI and Sector benchmarking group, by Nationality (ternary)



There were relatively large differences within 'Nationality (ternary)' for UHI compared to the Sector benchmarking group. 'UK' had the most positive results at UHI relative to the benchmark with an aggregate score 5.9% higher than the Sector benchmark. The category least positive relative to the Sector benchmarking group was 'Non-EU', with a score 3.4% higher than the Sector benchmark.

Compared to all responses, the most positive area within UK was Research culture. Here, the most positive statements relative to the benchmark were:	UHI	Sector	Difference	Significance	
1: The research ambience in my department or faculty stimulates my work	68%	62.0%	5.8%		
2: I have frequent opportunities to discuss my research with other research students	70%	67.0%	3.7%		
Compared to all responses, the most negative area within Non-EU was Professional development. The most negative statements were:					
1: My ability to manage projects has developed during my programme	83%	84.0%	-0.7%		
2: I have increasingly managed my own professional development during my programme	100%	83.0%	16.8%

There were relatively large differences within 'Ethnicity (binary)' for UHI compared to the Sector benchmarking group. 'BME' had the most positive results at UHI relative to the benchmark with an aggregate score 10.8% higher than the Sector benchmark. The category least positive relative to the Sector benchmarking group was 'Non-BME', with a score 3.8% higher than the Sector benchmark.

Compared to all responses, the most positive area within BME was Research culture. Here, the most positive statements relative to the benchmark were:	UHI	Sector	Difference	Significance

Compared to all responses, the most negative area within Non-BME was Research skills. The most negative statements were:

2: My understanding of 'research integrity' (e.g. rigour, ethics, transparency, attributing the contribution of others) has developed during my programme	87%	85.0%	1.4%
