# 4. GOVERNANCE, PLANNING & FUNDING ISSUES - Part One

#### 4.1. UHI STEM Hub and STEM Strategy

Sam Clark gave members a presentation on the UHI STEM Hub and strategy. Members noted that there were potentially funding opportunities in growth/ City deals, the Wood foundation, SDS and SFC. S Clark reported that currently work was focussed on the Highland area, but a more regional approach incorporating national strategy was sought.

Action: Members requested that S Clark provide an interim report to the next FERB meeting to include a statement on the national picture, as well as progress towards identifying potential funding sources.

#### 4.2. Innovation, Knowledge Exchange and College Innovation Fund

Joe Irvine gave members a presentation on UHI's Innovation and Knowledge Exchange (KE) offering. Members heard that current KE structures were developed from research clusters, hence their current focus on HE, but there are no barriers for this to be repurposed towards FE.

Members **agreed** that a regional approach in terms of coordination and collaboration around KE was needed. FERB members were encouraged to contact J Irvine to discuss opportunities for widening the current KE approach.

Action: J Irvine to produce a short report for the next FERB meeting giving progress to-date on diversifying KE opportunities, as well as case study examples of both HE and FE successes (e.g. ground source heat, renewables, forestry).

# 5. Audit, Risk Management & Reporting

#### 5.1. RISK MANAGEMENT - FE RISK REGISTER AND UHI HLRR

Members reviewed the FE Risk Register. Members heard that a new system had been rolled out across the partnership, and workshops with all risk register owners were planned for early 2019. Members also heard that there were no common risk appetite statements across the partnership. FERB members requested a report on the outputs of the risk register owners' workshop, noting that both Audit and the Risk committee working group would also be reviewing to be provide assurance. Members suggested that the workshop discuss how to set a maximum number of risks and seek common themes.

# 6. GOVERNANCE, PLANNING & FUNDING ISSUES - Part Two

#### 6.1. Review Governance Structures

G Coutts (Chair of Court) gave FERB members an update on activities to review the role of FERB and the potential establishment of a tertiary committee. Court has agreed to establish a sub-group to consider this new committee, in particular the implications for governance structure and Academic Council. The sub-group had met twice, and expected to meet again to consider effective proposals. Suggestions currently include a new tertiary committee; dual roles at both executive and governor level; increased frequency of meetings; more items with tangible and discernible options to improve decision-making.

The Chair of FERB **noted** that any final proposals would be discussed at FERB, including a special meeting of FERB if required.

#### 6.2. Assembly Update

Members heard that the Assembly Programme Board will meet on 12 December, with a view to establishing four working groups on student equivalence and experience; financial sustainability and efficiency; staff development and progression; and governance and accountability. There is an expectation that a collectively agreed programme of changes will be approved by the end of the academic year, followed shortly thereafter by a priotirisation exercise. FERB members requested that the timescales align with local partner Boards' meetings (around June 2019).

#### 6.4. Regional Outcome Agreement Development 2019-20 to 2021-22

FERB were asked to note that the timescales for the regional outcomes agreement 2019-20 to 2021-22 were extremely tight, especially as extensive consultation is required. M Antonson and D Rawlinson are working on a workshop for Partnership Council to consider draft proposed targets for the next three years and expect this to take place on the 7 December.

#### 6.5. Student Activity Monitoring 2018/19

FERB **noted** the student activity monitoring paper, and that the report indicated UHI is in a similar position to last year. With the exception of Perth College, Principals have provided confirmation that they anticipated meeting target at the end of the year. Perth College were anticipating meeting core target but falling short of the full ESIF target. Perth College MIS had however also reported that their credits were showing as being in a similar place to the previous year.

Members **agreed** that the next meeting of FERB in February 2019 was an appropriate time to review options in the case of unmet targets.

#### 6.6. Lews Castle College Update

FERB members heard that Lews Castle College UHI faces challenges in relation to student recruitment and demographics. Members **noted** the update paper, including updates on recent meetings and progress, particularly around the development of an action plan that encompassed franchising opportunities.

#### 6.9. 2018 Academic Partners/UHI Executive Office Financial Forecast Returns

Members **noted** the AP and EO FFRs. All APs are forecasting either decreasing surpluses or increasing deficits from 2019/20 to 2022/23, primarily as a result of a decrease in FE funding (SFC new funding model) over the period and increase in staff costs (cost of living increased and national bargaining). The risks around the new funding model are still under discussion.

Members heard that Moray College UHI had reduced staffing by 8% and rebalanced curriculum in order to balance their budget, and it should be expected that all Boards will be focused on efficiency activities.
